RESOLUTION 2025-0210-1

RESOLUTION ESTABLISHING SEWER RATES AND REPEALING PREVIOUS RESOLUTION OF SAID RATES FOR THE CITY OF BRONSON, KANSAS;

WHEREAS, the Governing Body of the City of Bronson, Kansas, has determined that rates set in Resolution 20216-0808-1 passed on August 8th, 2016 are no longer efficient for maintaining the municipal sewer wastewater utility system to provide sewer wastewater services to its customers, and

WHEREAS, the City of Bronson shall provide sewer wastewater service to its customers by rates, fees, and charges provided for in this resolution.

NOW, THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF BRONSON, KANSAS AS FOLLOWS:

SECTION 1. REPEAL RESOLUTION. Resolution Number 2016-0808-1 passed on August 8, 2016, is hereby repealed.

SECTION 2. RATES

Monthly sewer wastewater service charges will be based upon usage as follows:

A. Residential Sewer Rates

- 1. Sewer rates for residential properties, except for apartment buildings and duplexes with a single water meter serving the entire building, shall be based on the average water usage for March and April.
- 2. The residential sewer base rate shall be \$15.00, with an additional charge of \$4.00 per 1,000 gallons, as follows:

o 0 - 1,000 gallons: \$19.00

o 1,001 - 2,000 gallons: \$23.00

o 2,001 - 3,000 gallons: \$27.00

o 3,001+ gallons: \$31.00

B. Apartment and Duplex Sewer Rates

1. Apartment buildings and duplexes with a single water meter for the entire building shall be charged at the commercial rate rather than the residential rate.

C. Commercial Sewer Rates

1. Commercial sewer rates shall be based on actual water usage each billing period.

2. The commercial sewer base rate shall be \$30.00, with an additional charge of \$2.00 per 1,000 gallons of water used.

SECTION 3. RATE INCREASE EFFECTIVE 2026

Effective **May 1, 2026,** base sewer rates shall remain the same, with the additional charge per 1,000 gallons being modified as follows;

- The residential rate per 1,000 gallons will increase to \$6.33.
- The commercial rate per 1,000 gallons will increase to \$2.50.

SECTION 4. EFFECTIVE DATE

This resolution shall take effect and be in force with all sewer wastewater billing as of May 1^{st,} 2025.
