ORDINANCE NO. 270

AN ORDINANCE VACATING THE 70' STREET OF SCHOOL STREET BETWEEN BLOCK 10, LOTS 3,4,5,6 AND BLOCK 9 LOTS 7,8,9,10 ALL IN MRS. E WEIRS ADDITION ALL IN BRONSON, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BRONSON, KANSAS:

WHEREAS, a petition signed by owners of the adjacent property described herein, filed in the office of the Clerk of the City of Bronson, Kansas by Woodward, to vacate THE 70' STREET OF SCHOOL STREET BETWEEN BLOCK 10, LOTS 3,4,5,6 AND BLOCK 9 LOTS 7,8,9,10 ALL IN MRS. E WEIRS ADDITION all to the City of Bronson, Bourbon County, Kansas comes on for determination' and

WHEREAS, after having heard all the testimony on the said petition on the 12th day of August 2024 and all necessary to fully understand the true nature of this petition, the Governing Body of the City of Bronson passed and approved the petition of the petitioners to vacate those portions of streets and alleys described herein; and

WHEREAS, the City of Bronson Governing Body has given due and legal notice by publication as required by law; and that no private rights will be injured or endangered by the vacation and exclusion, and that the public will suffer no loss or inconvenience thereby, and that in justice to the petitioners, its requested relief in its petition should be granted.

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BRONSON, KANSAS:

SECTION 1. That THE 70' STREET OF SCHOOL STREET BETWEEN BLOCK 10, LOTS 3,4,5,6 AND BLOCK 9 LOTS 7,8,9,10 ALL IN MRS. E WEIRS ADDITION all to the City of Bronson, Bourbon County, Kansas be vacated and one-half of said land will go to each adjacent property owner.

SECTION 2. All rights for public utilities, rights-of-way, and easements for public service facilities on the described land will be retained by the City of Bronson.

SECTION 3. A copy of this ordinance will be filed with the Register of Deeds of Bourbon County, Kansas, and all costs of said filing and costs of vacating proceedings will be charged to the petitioners.

This ordinance shall be published one time in the official city newspaper and shall take effect and be in force from and after said publication.
